Privacy Notice for Website and Platform User

Pursuant to the Personal Data Protection Act B.E. 2562 and other related laws, including any further amendments thereof ("PDPA"), IHI ASIA PACIFIC (Thailand) Co., Ltd. (the "Company") hereby provide this Privacy Notice ("Notice") to inform you of the details with regard to the collection, use and disclosure of your Personal Data by the Company. This Notice shall apply to you as a user of the Company's Website and/or Platform.

1. Definition

- "Personal Data" means any information relating to a natural person, which enables the identification of such person, whether directly or indirectly, but not including the information of the deceased persons.
- "Sensitive Personal Data" means Personal Data pertaining to racial, ethnic origin, political opinions, cult, religious or philosophical beliefs, sexual behavior, criminal records, health data, disability, trade union information, genetic data, biometric data, or of any data which may engender the unfair discrimination against the data subject or affect the data subject in the same manner as prescribed by data protection laws.
- "Cookies" means small-sized files used for collecting information regarding website and internet usage, the Company collects such information from Cookies in order to facilitate the website users in using the Company's website.
- "Website" means website that the Company use to collect your Personal Data, including but not limited to https://www.ihi.co.jp/ihiapt/th/aboutus/ihi_apt/ and other websites that the Company may launch in replace of or in addition to the aforesaid website in the future.
- "Platform" means an online operating system created to collect and present information of products or services of the Company in the form of digital information for the purposes of business development. This shall include the Company's online platforms such as websites and applications developed by the Company as well as the websites or platforms developed by third-party service providers such as Facebook Page, YouTube, Hub Spot Application, and directory websites (e.g., http://thai.tech -dir.com/th/companies/203598), etc.
- "Legal Basis" means the justifiable ground to collect Personal Data as prescribed in the PDPA.

2. Categories of Personal Data which is the company collects

Your Personal Data which the Company will collect from the use of the Website is **General Personal Data** as follows:

- Cookies data and technologies alike such as Logfile, IP address, etc.

3. Source of Personal Data

The Company will collect your Personal Data directly and indirectly from the following sources:

From you directly by obtaining from the use of the Website or Platform, including through the message box "Contact Us" or "Apply Job" on the Company's Website or other Platform, including Auto Quotation Generation function, or via other channels of the Platform such as chat box on Facebook Messenger, Hub Spot Application etc., or comment box on Facebook Page, YouTube Channel of the Company etc.

4. Purpose of Collecting Personal Data

The Company will request for your consent to collect this cookie. If you do not give consent to install, you may not be able to access the Website easily and not fully effective.

5. Impact From the refusal in providing Personal Data

Cookies data

In the event that you do not consent to the use of cookies or you disable certain types of cookies, your use of the Website may be affected and incomplete which may cause inconvenienced experience to you or you may not be able to access certain areas of the Website.

Contact information and contact message

In the event that you do not provide us with some necessary personal data, the Company may not be able to contact you back or unable to completely respond to your inquiries or proceed with any actions as requested.

6. Disclosure, Transmission or Transfer of Personal Data

To achieve the objectives of Personal Data collection as stated in this Notice, the Company may in some case be required to disclose your Personal Data to persons or organizations including but not limited to the following:

Service providers and agents who have been hired by the Company for instance service providers on IT system or other databases, service providers on analysing the experience of the Website users, information on the Website usage in order to develop the Website and make it easily accessible and convenient to use etc.

Parent Company in Japan or affiliated companies or companies in the group, including the service providers and agents which those companies have been hired for instance service providers on IT system or other databases, service providers on analysing the experience of the Website users, information on the Website usage etc.

7. Retention Period of Personal Data

Cookies data

The Company will collect and retain your Personal Data for the period specified in the objectives of collecting the Personal Data in this Privacy Notice, in order to achieve the objectives of processing the Personal Data.

Contact information and contact message

The Company will collect and retain your personal data for not exceeding 3 years. from the date which you submitted the personal data to the Company via message box "Contact Us" or "Apply Job" on the Company's Website or other Platform, including Auto Quotation Generation function, or via other channels of the Platform such as chat box on Facebook Messenger, Hub Spot Application etc., or comment box on Facebook Page, YouTube Channel of the Company etc.

Nonetheless, the Company may retain all or part of your Personal Data for a duration beyond the period specified above for compliance with the law, any undertaking for debt collection, and to protect the legitimate rights of the Company, or to rebut any allegations made against the Company. In such case, the Personal Data may be retained for as long as it is necessary for the Company to abide with the specified objectives and/or for the duration stipulated by law.

8. Rights of Data Subject in the Processing of Personal Data

You have the following legal rights to your Personal Data collected by the Company:

- 1) Right on withdrawal of consent You may withdraw some or all of your given consent for the collection, use, and disclosure at any time throughout the period the Company keeps the Personal Data. Notwithstanding, the withdrawal of consent shall not affect the completeness or accuracy of the collection, use, or disclosure of Personal Data by the Company that the you have already given consent prior to the withdrawal;
- 2) Right to access and request for a counterpart of Personal Data you are entitled to request access to and obtain a copy of the Personal Data related to you, or to request the disclosure of the acquisition of the Personal Data obtained without your consent;
- 3) Right on the portability in sending or transferring of Personal Data you have the right to request the Company to send or transfer the Personal Data concerning you to another person pursuant to the condition prescribed by law;
- 4) Right to object on the collection, use or disclosure of Personal Data you are entitled to object to the collection, use or disclosure of your Personal Data by the Company pursuant to the condition prescribed by law;
- 5) Right on the erasure of Personal Data you have the right to request the Company to erase, destroy or anonymize the Personal Data to become anonymous data which cannot identify you pursuant to the condition prescribed by law;
- 6) Right to restrict processing of Personal Data you have the right to request the Company to restrict the use of your Personal Data pursuant to the condition prescribed by law;
- 7) Right on rectification of Personal Data you have the right to request the Company to rectify incorrect information or input data to any incomplete information;
